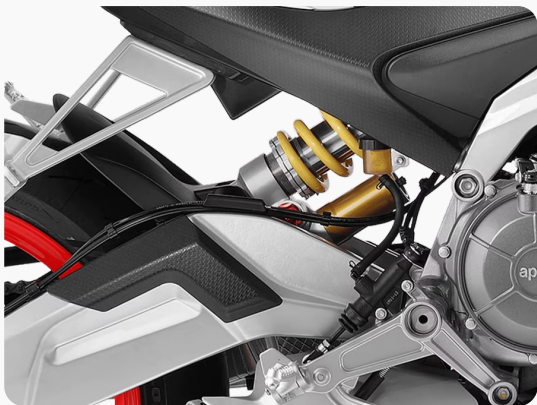
Cutting-edge braking
